

- (A) Wall anchors (2 pcs.)
- (B) Wall screws (2 pcs.)

IMPORTANT SAFETY INSTRUCTIONS:

Professional installation is strongly recommended. These instructions are provided for your safety. It is important that they are read carefully and completely before installation of the fixture.

For safety purposes, this lamp is equipped with a polarized plug (one prong is wider than the other). If the plug does not fit securely into your outlet, do not force it, contact a professional electrician. Use the plug with an extension cord only if it can be fully inserted into the cord's socket. Never alter the plug in any way. This fixture is designed for use with pre-installed LED tubes. To avoid the risk of fire, do not use the lamp with any other LED tubes.

WARNINGS:

All wires are connected. When unpacking, be careful not to pull wires as a bad connection may result. Do not connect electricity until your lamp is fully assembled. To reduce the risk of fire, electrical shock or personal injury, always turn off and unplug lamp and allow it to cool prior to replacing light tube. Do not touch the LED tube when fixture is turned on. Keep flammable materials away from lit tube.

Keep cord at least 3 feet away from cribs, bassinets and toddler beds. Keep out of reach of children under 3.

ASSEMBLY & INSTALLATION:

- 1. Carefully remove all parts from the box and remove plastic covering.
- 2. Drill 2 holes in the wall that align with the holes on the back of the light, and insert wall anchors (A).
- 3. Screw wall screws (B) into anchors and slide lamp body onto screws.
- 4. Plug into proper electrical outlet and test fixture.
- 5. Assembly is complete.

CARE INSTRUCTIONS:

Wipe clean with soft cloth.

Do not use polishes or cleaners, as they will damage the finish.
